8. INFORMATION AND BILLING SERVICES

8.1 GENERAL

The Company may, at the request of a customer, provide Information and Billing Services. All such requests will be reviewed to determine the feasibility of implementing the request and whether the Company wishes to provide the requested service or modification.
